6 The Sanctuary is located within a scheme of 10 similarly sized, terraced, self-contained units wrapped around a central, communal courtyard. The Sanctuary is situated in a prime pitch on Eden Office Park.

The building itself is steel framed with exposed pitched beams on the first floor. Internally, there is a spiral staircase linking both floors. There is an external staircase providing access to the first floor, meaning the ground and first floor could be made available separately.

Location


Eden Office Park is a well-known and established suburban business park located in Ham Green, Bristol.
